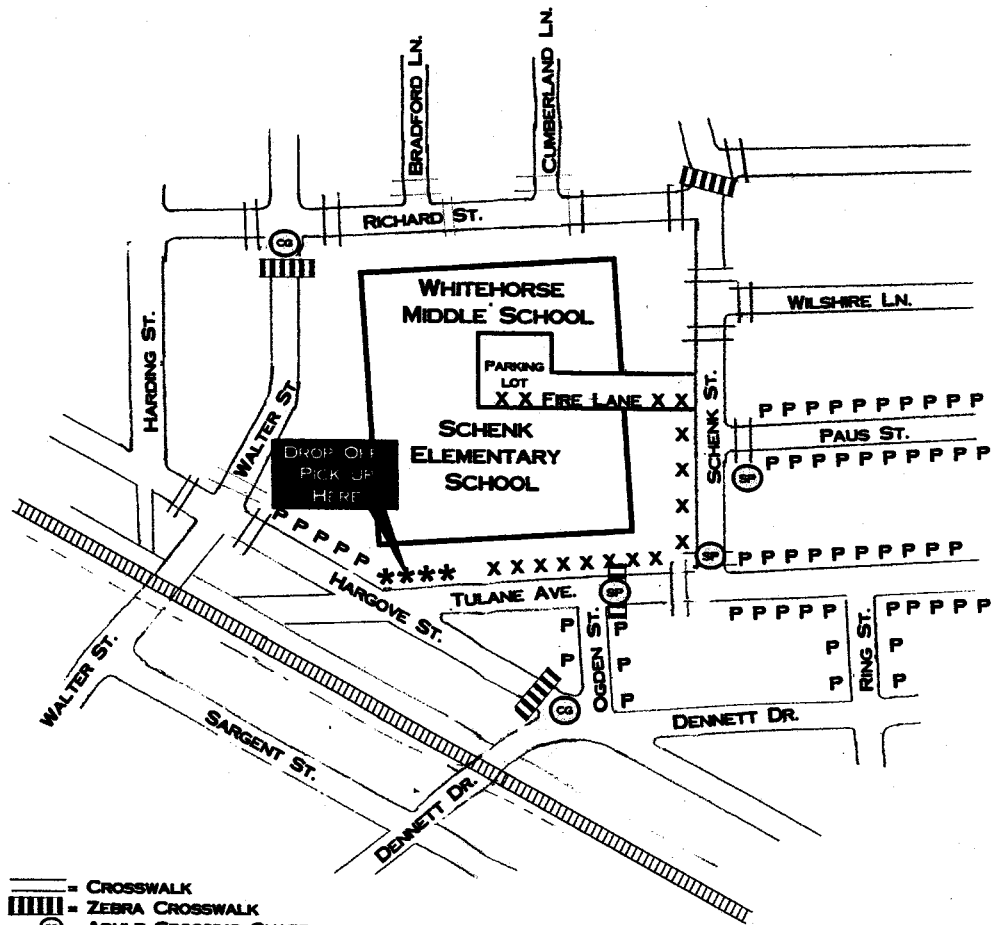
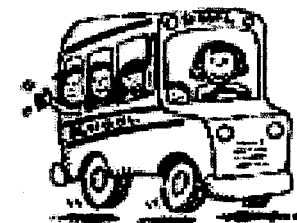




The Schenk Elementary School

Student Drop off and Pick Up Plan

The Schenk Elementary Safety Committee has created a safety plan so all students arrive at school and are picked up from school in a SAFE way.

The plan will reduce congestion on the side of the school (on Tulane) at both arrival and dismissal times and will keep our crosswalks visible for the safety of our children.

If you drive or walk your child to or from school, please read the guide and look at the map to determine a plan for getting your child to school safely.

If you walk to school...



Always use the crosswalks and crossing guards to cross streets. Crossing guards or student safety patrols are located at:

*Tulane and Schenk,
Dennett and Ogden,
Richard and Walter
and at Ogden and Tulane.*



If you drive to School...

We recommend that you park and/or drop off your children in the following areas:

- You are encouraged to drop your child off on *Tulane Ave.* in the No Parking area, which allows for stopping but you cannot leave your car unattended.
- You may park on *Tulane* or *Ring* and have your child cross with the safety patrol at *Schenk & Tulane* or at *Ogden & Tulane*.
- You may park on *Ogden* and have your child walk to the crosswalk on *Tulane*.
 - You may park on *Paus* BUT there is currently no crosswalk across *Schenk* at that intersection. A student safety patrol member is there to remind you to walk to a crosswalk to cross safely. The safety committee is currently working on obtaining a crosswalk in that area.

Please Keep in Mind...



Please observe all street signs and all traffic, parking and pedestrian laws.

Beware! The Madison Police Department will ticket any parent/caregiver who breaks these laws while dropping off or picking up their child.

- "No Parking" areas do allow for drop off or pick up but you cannot be leave your car unattended!
- "No Stopping, Standing, or Parking" means just that! Student pick up/drop off is NOT allowed.
- It is illegal to park within:
 - 4 feet of a driveway,
 - 20 feet of a crosswalk and
 - 30 feet of a stop sign.
- Motorists *must* yield the right of way to pedestrians crossing a street at a marked crosswalk where there is no traffic signal.
